General Information

Provincial/territorial emergency management organizations coordinate response activities, conduct planning and research, train, administer, and deliver disaster financial assistance programs in their respective province or territory. Funding agreements between emergency management organizations and AANDC help to ensure successful coordinated response and recovery efforts, better clarify roles and responsibilities, and support enhanced preparedness activities, including training and development of more robust community emergency plans for on-reserve First Nations.

For all aboriginal communities not considered as on-reserve First Nations communities, Provincial/Territorial emergency management organizations provide the same level of support as they do any community within their respective jurisdictions. These include Metis, First Nations in settlement areas and Inuit communities

Territorial Policing

The First Nations Policing Program (FNPP), is administered by Public Safety Canada

"A First Nations self-administered policing agreement is an arrangement between Canada, the participating province or territory, and the First Nations community. In these arrangements, the First Nation develops, manages and administers its own police service under provincial legislation. Independent police commissions provide for the impartial and independent oversight of police operations, and the police chief is responsible for the management and administration of the service."¹ As of Feb 22, 2013, over 80% - or 528 of 617 – of the eligible First Nations communities are under the policing program.

Please check with your Band leaders to see if your community is currently participating in the program. Please note that you might still have to find out exactly where the territorial policing boundaries are, but the website gives you contact information.

Civil Emergency Measures Act

AANDC National Emergency Management Plan

The legislation which covers disasters in Manitoba is called the Emergency Program Act.

There are a few definitions and legal requirements under the Act which are important to understand (note that this list is selected from a larger list and the text has, in some cases, been edited for length).

"co-ordinator" means the Executive Co-ordinator of the Emergency Measures Organization

"department" means a department of the government of Manitoba and includes a Crown agency, board or commission established by the government of Manitoba

"disaster" means a calamity, however caused, which has resulted in or may result in

- (a) the loss of life; or
- (b) serious harm or damage to the safety, health or welfare of people; or
- (b) wide-spread damage to property or the environment

"emergency" means a present or imminent situation or condition that requires prompt action to prevent or limit

- (a) the loss of life; or
- (b) harm or damage to the safety, health or welfare of people; or
- (c) damage to property or the environment

"emergency management program" means a program prepared by a department under section 8.1

"emergency plan" means a plan for preparing for, responding to and recovering from emergencies and disasters

"emergency preparedness program" means a program designed to achieve a state of readiness for emergencies and disasters

"local authority" means

- (a) the council of an incorporated community as defined in The Northern Affairs Act
- (b) the council of a municipality
- (c) the council of an incorporated city, town or village
- (d) the resident administrator or council of a local government district

(e) the Minister of Aboriginal and Northern Affairs with respect to Northern Manitoba as defined in The Northern Affairs Act

(f) the Minister of Conservation with respect to provincial parks, crown lands, wildlife management areas or refuges

(g) the Minister of Indian Affairs and Northern Development appointed under the Indian Act (Canada) with respect to a reserve as defined by that Act

(h) the Minister of National Defense with respect to a Canadian Forces Base

(i) the Minister responsible for national parks under the National Parks Act (Canada) with respect to a national park

"municipality" means

- (a) an incorporated city, town or village
- (b) a municipality as defined by The Municipal Act
- (e) a local government district, and
- (f) Northern Manitoba, as defined by The Northern Affairs Act

"private sector" means a person, partnership, unincorporated association or organization that is not a local authority and is not part of the Government of Manitoba or the Government of Canada.

Thus, local authorities are broadly defined to include representatives from both incorporated communities and some unincorporated communities. Ultimate authority, in terms of the approval of disaster plans, rests the coordinator. Further under the legislation, every local authority:

- (a) Shall establish a committee of members of the community to advise the authority on the development of emergency preparedness programs and emergency plans
- (b) shall establish and maintain a local emergency response control group
- (c) shall appoint a person from the local emergency response control group and prescribe the duties of that person including the preparation and co-ordination of emergency preparedness programs and emergency plans for the local authority
- (d) Shall prepare and adopt emergency preparedness programs and emergency plans and submit

(e) Shall prepare and adopt emergency preparedness programs and emergency plans and submit them to the co-ordinator for approval and co-ordination with other emergency preparedness programs and emergency plans.

Community History
